NEW GOAL

- 1. Receive updates on Martha T. Berry's progress toward achievement of at least a three star rating from the Centers for Medicare and Medicaid Five-Star Quality Rating System in preparation for work toward the two goals in the 2019 HSCB Annual Working Agenda.* Lead: Martha T. Berry Medical Care Facility**

Continue to coordinate how Martha T. Berry Medical Care Facility, Macomb County Community Mental Health and Senior Services can work together to facilitate and integrate services for seniors with issues of mental health. Lead: Martha T. NEW GOAL

 - A. Assist in the promotion of the:
 - i. No Vape Macomb Prenatal Anti-Vaping Campaign and its subsequent campaigns (to be developed) on marijuana and opioids.
 - ii. The Great Beginnings Infant-Toddler infant care and parenting materials.
 - iii. “Talking is Teaching” with the Rock-A-Bye Baby Readers
 - B. Collaborate in the support and promotion of the toxic stress and trauma Train the Trainer initiative.

2. If requested, receive and review requests for HSCB affiliation status from CHAP (now the Kids' Health Connections (KHC) with a tagline/descriptor "A Southeast Michigan CHAP"); the Macomb County Oral Health Committee; and Operation Rx. Lead Agency: HSCB Executive Council
3. Support the Census Bureau locally in Macomb County in its 2020 Census Operational Plan (when available) which documents the current design for conducting the 2020 Census. Lead: HSCB Executive Council
4. Explore collaborative strategies to address the growing health and human service needs of older adults in Macomb County. Lead:
