- Walk-in case management services are available from Easter Seals on Mondays -Thursdays, 10:00 A.M. - 1:00 P.M., at their office located at: 6800 E. 10 Mile Rd. Center Line, MI 48015
- Judson Center, located at 12220 13 Mile Road, Warren, MI 48088 opened an onsite integrated family health clinic on February 1, 2019. The center provides both primary and behavioral health care.
- The Lake House in St. Clair Shores merged with Gilda's Club Metro Detroit. Both provide services to families facing cancer. Their new name will be Gilda's Club Metro Detroit, Lake House location.

The Financial Empowerment Services Subcommittee (FESS) continues its work on the development of a collaborative plan to promote financial empowerment services throughout Macomb County. Toward that end, presentations from agencies offering financial services are scheduled at their monthly meetings.

In addition, several FESS member agencies attended the Macomb County Treasurer's "Show Cause" hearings on January 8, 2019 to set up a resource table and offer financial empowerment and other support services. "Show Cause" hearings are scheduled for Macomb homeowners who are delinquent in their property taxes and are about to be in foreclosure unless a payment plan is worked out.

While the homeowners waited for their appointment at the Treasurer's Office, select member agencies of the HSCB Financial Empowerment Services Subcommittee (Michigan Department of Health and Human Services, Macomb County Veteran Services, Macomb Community Action and Lakeshore Legal Aid) were available to discuss financial empowerment classes and other needed resources. These resource tables will be available at all future "Show Cause" hearings held annually in January.

Safe and Together Partnering with Agencies

The Safe and Together[™] model is an internationally recognized suite oftools and interventions designed to help human service professionals become domestic violence-informed. The model provides a framework for partnering with domestic violence survivors and intervening with domestic violence perpetrators in order to enhance the safety and wellbeing of children.

The child-centered Safe and Together[™] model derives its name from the concept that children are best served when we can work toward keeping them safe and together with the non-offending parent (the adult domestic violence survivor) Since its first meeting in August 2016, the Safe and Together Committee has been working to bring Safe and Together key principles to HSCB member agencies.

Systems rarely have an accurate picture of the relationship of domestic violence to other key initiatives such as differential response or trauma.

Many agencies have not systematically reviewed their policy and protocols from a domestic violence-informed perspective.

Collaboration across systems is one of the key features that help adult and child survivors. moved to partnering with agencies who have expressed a readiness to implement Safe and Together principles in policy and services.

MATRIX Data Being Tracked

The MATRIX electronic referral system has been active since July 2018



and statistics are being collected . These statistics include, at a minimum, the total number of requests, the needed services, and the requester's zip code.

Data from participating HSCB member agencies indicated that, to date:

- A total of 483 surveys have been completed.
- The top three zip codes were from 48035 (Clinton Township), 48066 (Roseville), 48043 (Mt. Clemens)
- The top three needs were: food, housing/shelter, employment.

When the user has a need <u>not</u> included in the MATRIX survey, there is the opportunity for the user to indicate that need. Examples of the types of services in this category include such things as stress management, hearing aids, a ramp for a handicapped individual, home care, foreclosure help, a vehicle, burial benefits etc. Then an individualized email of referral resources is sent to help with that specific problem.

In addition, users may also request the link to the Right Connection. During the month of March 2019, the link to the Right Connection online services directory was requested by seventy three (73) MATRIX users. Of these, twenty one (21) requested thirteen (13) additional services. Also, HSCB Work Group Chairs are contacted to provide suggested other goals. The Agenda is then drafted and divided into three categories:

- 1) Executive Council Initiatives,
- 2) State/Federal Initiatives, and
- 3) Local Initiatives.

Under each of these above three categories, the goals are further divided into *New Goals* and *Continuation Goals*.

HSCB Executive Council Directors may add goals to the Working Agenda at the meeting in which the Agenda is expected to be approved or any time during the year when a collaborative need is identified.
