Dear Prospective Bidder:

Macomb County Community Mental Health Services (MCCMHS) is inviting responses to a Request for Proposal (RFP) for **Specialized Residential Services**. The successful bidder(s) must be ready to contract with MCCMHS for Residential Services any time on or after the award date.

MCCMHS is seeking to **add to its panel** of Specialized Residential service providers. Therefore, new providers (or current providers) may submit bid proposals in response to this RFP. This RFP is seeking providers of Residential Personal Care and Community Living Supports services in the residential setting.

Please be as concise and succinct as possible with your bid documents. Your submission should provide enough information to fully describe your agency and its operations. If possible, please limit your submission to no more than fifty (50) pages (exclusive of dividers).

All proposals will be evaluated with reference to the following criteria:

- The bidder's specialized knowledge and expertise to provide the services outlined in the RFP
- The history and/or experience of the bidder in providing these services will be heavily considered
- The ability, capacity, and skill of the bidder to perform the contract and to provide the services required
- The cost of requested service
- Organization and completeness of the proposal
- The bidder's history of favorable results from PIHP and accreditation audits, consumer satisfaction, and quality assurance activities and outcomes.
- The number and scope of conditions, if any, attached to the bid.
- Whether the bidder is presently in default to the MCCMHS' Board for any reason.
- The number and scope of recipient rights complaints and/or compliance issues associated with the bidder and/or the bidder's parent organization.
