

## Macomb County Community Mental Health Self-Determination Training – Direct Employment Model

## **Training for Staff Hired through Self-Determination:**

Staff hired through self-determination arrangements must meet Medicaid Qualified Provider requirements such as; *be at least 18 years of age, able to prevent transmission of communicable disease, able to communicate effectively to follow IPOS requirements, emergency procedures, and to report on activities performed; and be in good standing with the law (i.e., not a fugitive from justice, a convicted felon who is either under jurisdiction or whose felony relates to the kind of duty to be performed, or an illegal alien).* 

The following grid details the free or low-cost training for qualified staff hired through self-determination. If staff do not meet the minimum training requirements, the Financial Management Service (FMS) will not be able to pay the staff with the self-determination budget dollars. It is the responsibility of the Employer of Record and/or Managing Employer to track training.
