SUBJECT: NOTICE OF POLICY UPDATE

Revised Policy	<u>Update</u>
MCCMH MCO Policy 8-008, "Behavior Treatment Plans"	Updated language in Section V.O. to comply with the Michigan Department of Health and Human Services (MDHHS) updated behavior treatment plan technical requirement. Revised Section V.Q. to detail that current expedited reviews and approvals for proposed behavior treatment plans will occur within forty-eight (48) hours. Added language to Section V.S.(3-4) to revise the scope of the Behavior Treatment Plan Review Committee (BTPRC).
MCCMH MCO Policy 3-015, "Contracted Provider Mandatory Training and Workforce Development"	Added language in Section IV.D. to define 'Prescribers.' Added language in Section V.H. to include additional third-party industry standard training courses that may be acceptable for MCCMH. Updated Section VII. to include pertinent references and legal authorities.
MCCMH MCO Policy 12-001, "Access, Eligibility, Admission, Discharge"	Revised language in Section IV.E. to define 'Medical Necessity Reviews' conducted by MCCMH's Managed Care Operations (MCO) Division. Added language in Section IV.F. to define 'Mild to Moderate Mental Illness' for both children and adults. Added language to Section V.F. related to level of care transitions. Providers are directed to refer to the MCCMH Change in Level of Care Procedure which details operational guidelines for level of care transitions. Added language in VI.B.2(e) to detail that CCBHC- covered services shall not be denied to any person who meets eligibility criteria, and such services must be

	detailed in the individual plan of service (IPOS) and documented in the person's electronic medical record (EMR).Updated exhibit document references to include applicable procedures for admissions, enrollments, and transfers.
MCCMH MCO Policy 12-002, "Utilization Management System"	Updated language to detail MCCMH's utilization management system for monitoring and evaluating the provision of medically necessary services.
MCCMH MCO Policy 12-004, "Service Authorizations"	Added language in Section VI.D. to detail the various internal and external utilization management (UM) decision-making tools that MCCMH uses to make benefit coverage determinations.
MCCMH MCO Policy 12-005, "Specialized Residential Services"	Updated language to define and detail the scope of specialized residential services (SRS) covered and provided by MCCMH and its network.
