What to do in a Behavioral Health or Substance Use Crisis



911 vs. 988

911: For immediate emergencies like medical, fire, or crimes in progress.



988 Suicide & Crisis Lifeline:

For mental health crises, including suicidal thoughts, self-harm, emotional distress, and substance use concerns. Provides free, confidential support and connects callers to local resources.

Macomb County Community Mental Health (MCCMH) serves as the local 988 call center for Macomb County residents. Call the MCCMH Crisis Line for 24/7 support: 586-310-9700

Substance Use Engagement Center:

The Substance Use Engagement Center is a short-term crisis intervention facility that provides a supervised, supportive setting for individuals with substance use disorders. Individuals are provided with a safe place to have a meal, take a shower, and talk to caring staff. Services are typically provided by Peer Recovery Coaches.

The MCCMH Engagement Center is available 24/7 for Macomb County residents who are actively using substances or are under the influence.

Mobile Crisis Services

MCCMH's Mobile Crisis services assist children and adults in Macomb County experiencing mental health and substance use crises, including suicidal thoughts, self-harm, and situations where they pose a risk to themselves or others.

To reach the Mobile Crisis Team, call the MCCMH Crisis Line at **586-307-9100** and ask for the Mobile Crisis Therapist. They can assess situations by phone, help access services, and arrive on-scene within an hour when needed, in coordination with law enforcement.

Adult and Children's Mobile Crisis Services are available 24/7.

Same Day Access at Behavioral Health Urgent Care Clinics

Individuals in need of mental health or substance use disorder services (crisis or non-crisis) can access same-day services and intake with a walk-in assessment at the following locations, Monday through Friday, from 8:30 a.m. to 3 p.m.:
